### From Executive Director Becky Morris



I recently moved my son, my oldest child, into a college dorm for the very first time. It was a day full of so many different emotions. I am excited for all the possibilities in front of him. I feel sad for myself because of how much I will miss seeing him every day. I am worried about the challenges he will face and if he is ready for them. As hard as it can be to juggle all of those emotions, that is the life of a parent! It is important work and rarely easy. We love, cheer on,

encourage, guide, and worry - whether they are 18 months or 18 years old.

When I think of the 350 children and youth (aged infant – 21 years old) who were served by CASA of McHenry County over the past year because of a parent's inability to provide a safe home for them, I find myself, again, with so many different emotions. I feel sad for the children who are experiencing trauma at home. I am heartbroken for the ways these kids' lives are turned upside down when they enter the foster care system. I am frustrated by a less-than-perfect child welfare system. I worry about the abundance of challenges these kids will face due to things completely out of their control. I fear for how this time in their life will affect them long-term.

But then I also look at the 177 volunteers in our county who stepped up to advocate for those kids and I feel so much more! I am proud of the work these selfless volunteers do for kids who need someone to be on their side. I feel grateful for the board members and generous donors who give sacrificially to ensure every child in McHenry County is supported and protected while navigating the tough road of foster care. And I feel hopeful. I have hope that these kids' stories don't begin and end with trauma and displacement. Their stories are still being written as CASA Advocates give them a voice and fight for their best interest to be heard and considered at every turn.

Thank you for the part each of you have played in this past year to do the important work of "parenting" the children in our community. I am honored to do this vital work in partnership with you.

## **Advocating for the Child's Best Interest**

Joe\* has been at CASA for less than one year and has already made a significant impact on the three children he advocates for. He stood by them during challenging times and was always there when they needed him most, no matter what! When he came across roadblocks to seeing the kids in the home where they were staying, Joe visited them at school to ensure they had a voice while in the foster care system. Joe spoke up when he noticed safety issues in their foster home and then helped the kids transition to their new foster home.

When he noticed the oldest boy had fallen behind academically due to frequent school changes, Joe arranged tutoring (paid for by CASA's Family Support Fund) that helped the boy catch up nearly three grade levels in just one summer! Ron also took the initiative to learn about IEP's (Individualized Education Plans at the schools), helping the foster parent better understand the process and advocate for the boy's educational needs. Joe is the type of Volunteer Advocate who is always thinking outside the box for things to do with the kids, building trust along the way, and ensuring their best interest is always taken into account – inside and out of the courtroom.




### Jay Schwarzrock CASA Board Member
